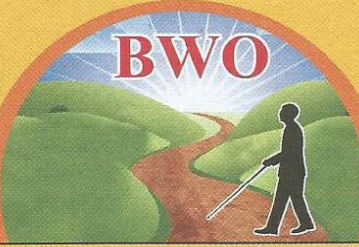

WE PROVIDE AND DISTRIBUTE BRAILLE DIGEST AND BOOKS, SLATE, STYLUS, TAYLOR FRAME, TYPES IN FREE OF COST.

SPORT ACTIVITIES:

WE ARRANGE SPORTS ACTIVITIES LIKE CRICKET TOURNAMENT IN STATE AND NATIONAL LEVEL TO BRING THE BEST OUT OF THE VISUALLY IMPAIRED SUCCESSFULLY PAST TEN YEARS.

OUR MUSIC ACADEMY ONLY FOR VISUALLY IMPAIRED WAS INAUGURATED BY SHRI SHANKAR MAHADEVAN IN THE YEAR 2015. DUE TO PRESENT PANDEMIC WE ARE PLANNING TO PURSE THE VIRTUAL MUSIC CLASSES.

IN COMING DAYS WE ARE PLANNING FOR B.ED. COURSE AND SKILL DEVELOPMENT COURSE FOR OUR VISUALLY IMPAIRED.

LOOKING FORWARD FOR YOUR FINANCIAL SUPPORT AND ASSISTANCE TO RUN THE SAID PROJECTS SUCCESSFULLY AND CONTINUOUSLY.
